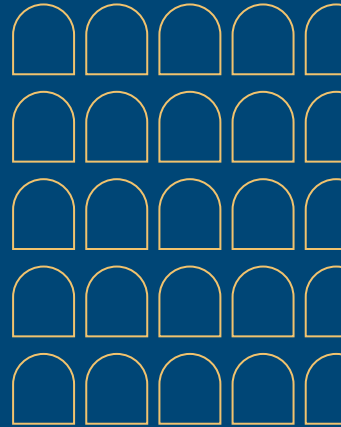

PROGRAMME OVERVIEW

The STG's Master in Transnational Governance examines the most pressing policy issues of our time through a multicultural and interdisciplinary lens focused on pivotal case-studies. You will learn how a collaborative approach to policy-making can optimise resources, broaden impact and strengthen partnerships worldwide.

A full-time two-year residential programme, the master's goes beyond mere academic theory, building a solid foundation of tactical, analytical and diplomatic skills aimed at turning today's learners into tomorrow's leaders.

YEAR 1 – FOUNDATION

First-year coursework focuses on a comprehensive understanding and analysis of transnational governance. The curriculum is spread across four core modules:

CORE MODULE 1

Foundations of Transnational Governance

Practices, structure and key figures in transnational governance and its global implications for democratic systems.

CORE MODULE 2

Tools of Transnational Governance

Legal and statistical language and tools essential to understanding the impact of transnational governance.

CORE MODULE 3

Economics

Economic insights into the ramifications of international redistribution, economic transformations and specific regulatory legislation.

CORE MODULE 4

Professional Development Skills

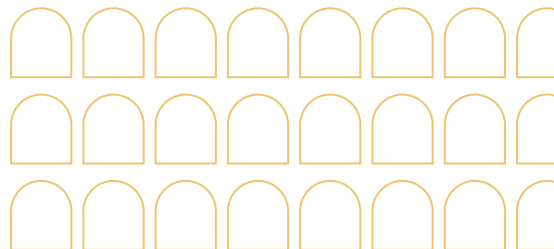
Interactive workshops designed to hone key professional skills such as negotiation, professional skills, project management and conflict resolution.

YEAR 2 – SPECIALISATION

Second-year students specialise in one of the areas of transnational governance and produce a comprehensive master project focused on their chosen specialisation.

Specialisation Tracks:

- Public Leadership, Management and Administration
- International Political Economy and Regulation
- Politics, Democracy and Citizenship
- Peace, Conflict and Security
- Digitalisation, Technology and Media
- Climate, Migration and Health
- Gender and Diversity (planned)

STUDENT INTERNSHIP

An integral part of our master's training includes a compulsory internship at one of our international partner organisations. Equal to 10 ECTS credits, this first-hand opportunity provides students with critical know-how and practical working experience for future careers in international organisations, civil society, think tanks, research institutions and international corporations.

During the Master, students can opt to study abroad, spending their third semester at an STG partner university in Europe or worldwide.
